#### Mind & Memory Endowment Fund Up Another \$100,000!

Philanthropists Peter and Gayle Grimm founded the Mind and Memory Endowment Fund last year, for the Council on Aging of Martin County to promote innovation and access to community-based programs for brain health and memory care. They hope others will join them in investing in our community's seniors experiencing memory problems and work to be proactive in addressing issues associated with memory loss.

Through the Mind and Memory Endowment Fund, the Council on Aging at the Kane Center is able to strengthen its existing brain health and dementia care programs as well as develop new ones. The fund benefits programs like early intervention resources to help those with mild cognitive impairment keep their brains and bodies active and connect with a peer support group. It also supports free counseling services for individuals with dementia and their caregivers and free ID locator bracelets, recently donated by WellMed, to help law enforcement find individuals who have wandered from safety. In addition, the fund supports therapeutic enrichment programs including music and art therapy, community outings, brain fitness, veterans support, and specialized exercise classes.



The need for community-based support for individuals living with memory disorders is growing every day. There are more than 7,300 probable cases of Alzheimer's disease in Martin County--and many others who are undiagnosed, or who have other types of dementia and memory disorders. By providing a comprehensive continuum of care from the earliest indication of memory changes to the late stages of dementia, these individuals and their families will be connected to a strong support system that will enhance their quality of life.

"We are grateful to the Grimms for their longtime support of memory care programs at the Kane Center," said Karen Ripper, President and CEO of the Council on Aging. "Through their generosity we were able to bring the Integrative Memory Enhancement Program to the Kane Center in 2016, a specialized program for individuals at the earliest stages of memory loss. Now, with the Mind and Memory Fund, we can continue to innovate and expand access to care."
